- **RuleBook** – Our RuleBook maintains the definition and hierarchy of your rule structure and provides a complete library of all your tax rules.
- **STAAR Algorithm** – STAAR (Synchronized Tax Attribute Assignment Routine), our proprietary algorithm, drives tax accuracy. When more than one rule matches the data elements of a transaction line, STAAR properly analyzes which rule should be used to derive correct taxability.
- **Exception Alerts & Reports** – TaxView provides reports that continually alert you to transactions that may have errors, don't map to a rule or need further research. In addition, more than 60 management reports are delivered to help with tax analysis and compliance reporting.
- **TV Navigator** – Our proprietary dashboard, provides a concise, batch-level view of every key piece of information that should be reviewed for the period. It also displays your gross and net tax standings for the batch and where your current rule approvals stand.
